## RECTOR'S DECISION

### *On the Procedure Fees for Settlement of Academic Debts in 2026/2027 study year*

1. Attendees of study courses pay a fee for one credit point:
  - 1.1. EUR **45** in Bachelor study programmes;
  - 1.2. In study programme "Veterinary Medicine":
    - 1.2.1. EUR **110** if **no** student status at LBTU;
    - 1.2.2. EUR **60** if **is** student status at LBTU;
  - 1.3. EUR **50** in Master study programmes.
  - 1.4. if the study course is implemented in English, a coefficient of 4 (four) shall be applied to the fee per credit point.
2. The Value Added Tax is not applied to the above mentioned payments according to Points 4 and 7 of Point 12, in Article 52 of the Law of the Republic of Latvia on the Value Added Tax.
3. The procedure of charging a fee for academic debts:
  - 3.1. the instalment for settling an academic debt is paid into the bank account indicated in the LBTU website (<https://www.lbtu.lv/en/contact-information>);
  - 3.2. the payment has to be addressed to the faculty where an academic debt is to be settled;
  - 3.3. the purpose of the payment has to include the title of a respective study course.

6. The Rector's decision No. 4.3.8/125 "On the Procedure of Charging Tuition Fees and Fees for Settlement of Academic Debts" as of June 4, 2025, is declared to have no legal force from 01.09.2026.
